



Subject to the following Terms and Conditions, authorized and participating Jacuzzi® hot tubs dealers in the USA and Canada (excluding Quebec and “Le Club Piscine” stores in Quebec or Ontario, Canada), are extending to customers an instant rebate of up to \$1,500 off select models of Jacuzzi® hot tubs at the time of purchase. This promotional offer is subject to the following terms and conditions, and **Dealer participation is required**. Check with your local authorized Jacuzzi® hot tubs dealer prior to purchase to find out if they are participating, and the instant rebate amounts being offered.

TERMS AND CONDITIONS OF PROMOTION

Promotion Dates: November 16, 2018 – December 10, 2018

Subject to these Terms and Conditions, eligible hot tub end-user/buyer (“Buyer”) can receive up to \$1,500 off the purchase price of select models of Jacuzzi® hot tubs via an instant rebate (“Discount Offer”). Buyer will receive up to \$1,500 off the purchase price of an Eligible Hot Tub (defined below) via an instant rebate (the “Discount Promotion”). (The exact amount of discount varies by Dealer, with \$1,500 typically being offered off J-500™ series hot tubs, and other discounts off other Eligible Hot Tubs.) Buyer will receive the discount at the time of purchase from participating Jacuzzi® hot tubs dealers (“Dealer”) only, and Buyer must mention the Discount Promotion to a participating Dealer before discussing a sale price. Discount Promotion must be reflected on the sales invoice and applied by participating dealer at the time of purchase. Discount Promotion cannot be delivered or applied to the Buyer’s purchase after the sale nor applied to sales prior to the Promotion dates. Jacuzzi Hot Tubs (“Jacuzzi”) will not issue any check or payment directly to Buyer.

The Discount Promotion applies to the purchase of any Eligible Hot Tub, subject to these Terms and Conditions. Eligible Hot Tub must be purchased from a participating, authorized Dealer in the USA or Canada (excluding Quebec and “Le Club Piscine” stores in Quebec or Ontario, Canada) and original date of purchase by Buyer must have occurred between November 16 – December 10, 2018. Eligible Hot Tub purchases for the promotion vary by Dealer, but generally include new, first quality or red tag Jacuzzi® brand model hot tubs purchased during the applicable Promotion Dates (“Eligible Hot Tub”). Demo, reconditioned, “as is” or any other non-first quality hot tubs are typically NOT ELIGIBLE for the promotion. Dealer participation is required for the promotion. Buyer must confirm Dealer’s participation prior to purchase. See a participating Dealer for the models the Dealer is offering for this Promotion, and the instant rebate amounts being offered. The promotional offer is not valid on exchanges or returned products or in conjunction with other offers. Offer not valid on prior purchases, or purchases after the Promotion Dates. If Buyer cancels the purchase of an Eligible Hot Tub, or cannot take delivery of the Eligible Hot Tub on or before 60 days after the Promotion end date, Buyer forfeits the discount.

Jacuzzi is not responsible for late, incomplete or misdirected Sales Slips or registered warranties, regardless of the reason.



Eligible Hot Tub warranty should be registered within 60 days of the date of purchase. Warranties are not transferrable. Jacuzzi is not responsible for late, incomplete or misdirected Sales Slips or registered warranties, regardless of the reason.

Eligible Hot Tubs must be installed in the USA or Canada (excluding Quebec, Canada). Participating Dealer and Jacuzzi reserve the right to modify, substitute or end Promotion without notice. Jacuzzi and those involved in the development, handling, production, implementation and distribution of the Promotion, and their advertising or promotion agencies, parent companies, agents, officers, employees, licensees, subsidiaries or affiliates, service providers, credit suppliers, or any other persons/entities directly associated with the Promotion (collectively "Promotion Entities") are not responsible or liable for multiple or late submissions, redemption forms that are entered by other than human means (such as by an automated computer program or any non-human mechanics), or that are late, destroyed, incomplete, lost, misdirected, forged, damaged, mutilated, tampered with or promotion forms that are otherwise not in compliance with these Terms and Conditions (whether due to the fault of the entrant, Jacuzzi, Dealer, or any other Promotion Entity), and all such Promotion entries that do not strictly comply with the Terms and Conditions will be disqualified. Any person attempting to defraud Jacuzzi or tamper with Promotion in any way will be prosecuted to the full extent permitted by law, will not receive discount, and will be charged the full amount for the hot tub(s) in question.

Promotion Entities shall not be liable for any injury, damage, loss, expense, accident, delay, inconvenience or irregularity that may be caused or contributed to (1) by any wrongful, negligent or unauthorized act or omission on the part of a Promotion supplier or any of its agents, servants, employees or independent contractors, (2) by any wrongful, negligent or unauthorized act or omission on the part of any other person or entity not an employee of Jacuzzi, or (3) by any other cause, condition or event whatsoever beyond the control of Jacuzzi or its parents, subsidiaries and affiliated companies. Jacuzzi shall not be liable for any injury, damage, loss, expense, accident, delay, inconvenience or irregularity arising out of or relating to the discount provided in these Promotion, even if caused by the negligence of Jacuzzi.

Buyer agrees to indemnify and hold harmless the Promotion Entities, including without limitation Jacuzzi, and each of them from and against any and all liability, damages, costs, attorney fees, etc. incurred with regard to any claim by any person(s) in connection with any and all of the rights and benefits conferred by Buyer or Dealer upon the Promotion Entities in these Terms and Conditions. Buyer further agrees to indemnify and hold harmless Promotion Entities from any and all liability resulting or arising from the Promotion, to release all rights to bring any claim, action or proceeding against Promotion Entities, and hereby acknowledges that said Promotion Entities have neither made nor are in any manner responsible or liable for the payment of any discount.
